\*Thermal styling is done with a curling iron or flat iron only.

\*A Shampoo and Blow-dry includes a shampoo and blow dry with a round brush style.

\*A Shampoo and blow dry with thermal styling include a shampoo and blow dry with a round brush style and finished with a curling or flat iron

**Appointment Date and Deposit/CC Authorization:** \_\_\_\_\_ initials

Your appointment date(s) and service(s) will be secured when the signed contract and credit card authorization (Visa or Mastercard only) are received and completed. All bookings for weddings are made on a “first-come-first-served” basis. No dates will be guaranteed without a signed contract and deposit.

All services scheduled must be held with a credit card valid through the date of service. We require a valid credit card to be authorized and kept on file, a signed agreement from the Bride, and a deposit for any off-site services.

**Off-Site Services & Payments:** \_\_\_\_\_ initials

If we are traveling to you (minimum of 6 guests receiving services), a \$150 travel fee (in addition to service costs) for the first 2 stylists, (plus a \$50 fee if applicable for each additional stylist needed) is required as a deposit upon booking. An additional travel fee may be required determined by the date of the event and the amount of travel miles required. The travel fee including payment of the total service costs must be paid by credit card prior to the stylist(s) arrival on the day of the event. The travel fee is not considered gratuity, gratuity can be made to the individual stylist on the day of your event in cash. All fees are nonrefundable. **We do not accept individual payments on the day of the event.**

**In House Services & Payments:** \_\_\_\_\_ initials

Your balance can be paid by cash, check or credit card. If paying by check you MUST pay no less than 7 days (1 week) prior to your event. If paying by cash or credit, you may make your payment before or after receiving your services on the day of your event.

**Contract & Appointment Changes:** \_\_\_\_\_ initials

All agreements will be made in writing. Any changes/additions to guests or wedding party members requesting additional services after the contract is signed must be submitted in writing (email). Changes will be accepted up to 14 days prior to the service date. The Bride/individual signing this contract is the only person permitted to authorize, submit, and change any arrangements for the wedding party. Contracts and changes made by anyone other than the individuals signing or listed on these contracts are not allowed and considered invalid. Gina Shaffer (Owner) is the only authorized personnel to accept and make any requested changes.

**Cancellations:** \_\_\_\_\_initials

## **In-house:**

We do require a two week (14 days) advance notice of cancellation. In the event that any appointment is cancelled less than two weeks (14 days) prior to your appointment, your credit card will be charged for 50% of the cost of services. If a cancellation is made within one week (7 days) or less, your credit card will be charged for 100% of the cost of services.

## **Off-Site:**

We do require a three week (21 days) advance notice of cancellation. In the event that an appointment is cancelled less than three weeks (21 days) prior to your appointment, your credit card will be charged for 50% of the cost of services. If a cancellation is made within 2 weeks (14 days) or less, your credit card will be charged for 100% of the cost of services. Cancellations due to emergencies or unforeseen circumstances are considered on a case-by-case basis and are completely at the management's discretion.
